Manual bids shall not be accepted.

- 2.** Not more than one tender shall be submitted by one bidder or bidders having business relationship. Under no circumstance will father and his son(s) or other close relations who have business relationship with one another (i.e., when one or more partner(s)/director(s) are common) be allowed to tender for the same contract as separate bidders. A breach of this condition will render the tenders of both parties liable to rejection.
- 3.** Bidder who has downloaded the tender from the college website www.kalindi.du.ac.in and Central Public Procurement Portal (CPPP) website <https://eprocure.gov.in/eprocure/app>, **shall not tamper/modify the tender form including downloaded price bid template in any manner.** In case if the same is found

4. Intending bidders are **advised to keep checking the college** website www.kalindi.du.ac.in and **CPPP website** <https://eprocure.gov.in/eprocure/app> **regularly till closing date of submission** of tender for any corrigendum / addendum/ amendment.
5. **EMD Payment – Rs.35000/-** (Rupees Thirty Five Thousand only) in favour of “The Principal, Kalindi College, University of Delhi”, Payable at Delhi valid for a period of three months.

Demand draft of EMD favoring **Principal, Kalindi College**, payable at Delhi, should reach the college before the end date and time of bid submission. Failing which offer will be liable for rejection. Bidders, however have to attach scanned copy of EMD documents along with their e- tender.

SECTION – 2

INSTRUCTIONS FOR BIDDERS

1. **GENERAL** – The present tender is being invited for providing Mathematica latest version perpetual desktop license as specified in SCOPE OF WORK (Annexure – II)
2. **BIDDERS** – Bidder is the Person/Firm who places a bid under this application system. Bidder must be a sole producer/sole authority to supply Mathematica software in India.
3. **Eligibility of the Bidders –**
 - a) All agencies that are providing similar kind of services for at least last three consecutive years and having annual turnover of Rs. (₹) 2 Crores or more during last three financial years ((attaché proof Audited Balance Sheet and Profit & Loss Accounts of 2018-19, 2019-20 and 2020-21).
 - b) The bidder should have the experience of at least three years with similar work in any of the reputed MNCs/Autonomous Institutions/Central or State Universities/Public Sector Undertakings of the Government of India or Government of NCT of Delhi or any other State Government or Public- Sector Banks. Provide details of work order and completion certificate of last three years.
 - c) The bidder should have awarded single work order for at least Rs. (₹) 5 lakh rupees during the last three consecutive years (2019, 2020, 2021 calendar years) from the date of closing the bid.
4. **QUALIFICATION OF THE BIDDERS** – The bidder shall not engage any sub-contractor or transfer the contract to any other person in any manner.
The bidder shall submit full details of his ownership and control or, if the Bidder is a partnership, joint venture or consortium, full details of ownership and control of each member thereof.
Bidder or members of a partnership, joint venture or consortium shall submit a self-attested copy of PAN card under Income Tax Act.
Bidder must submit copies of all documents required, duly self-attested, along with technical bid of the tender.
Canvassing or offer of an advantage or any other inducement by any person with a view to influencing acceptance of a bid will be an offence under Laws of India. Such action will result in the rejection of bid, in addition to other punitive measures.
5. **ONE BID PER BIDDER** – Each bidder shall submit only one tender either by himself or as a partner in joint venture or as a member of consortium. If a bidder or if any of the partners in a joint venture or any one of the members of the consortium participate in more than one bid, the tender applications are liable to be rejected.
6. **COST OF BID** – The bidder shall bear all costs associated with the preparation and submission of this bid and the College will in no case shall be responsible or liable for those costs, regardless of the conduct or outcome of the tender process.

- h) Undertaking (Annexure VI)

The bidder is expected to examine all instructions, Forms, Terms and Conditions in the Tender document. Failure to furnish all information required by the tender document or submission of a tender not substantially responsive to the tender document in every respect will be at the bidder's risk and may result in rejection of his bid.

The bidder shall not make or cause to be made any alteration, erasure or obliteration to the text of the Tender document.

Clarification of Tender Document – The bidder shall check the pages of all documents against page number given in indexes and, in the event of discovery of any discrepancy or missing pages the bidder shall immediately inform the Office of Section Officer, Kalindi College.

In case the bidder has any doubt about the meaning of anything contained in the Tender document, he shall seek clarification from the teacher in – charge of the respective department before submitting his bid. All communications between the bidder and the college shall be carried out in writing.

Except for any such written clarification by the college, which is expressly stated to be an addendum to the tender document issued by the Office of Principal, no written or oral communication, presentation or explanation by any other employee of the College shall be taken to bind or fetter the college under the contract.

8. **PREPERATION OF BIDS** –

Language: The bids and all accompanying document shall be in English.

Documents comprising the bid: Tender document issued for the purposes of tendering as described in Clause 6 and any amendments issued shall be deemed as incorporated in the Bid. Upload one copy of the Tender document and Addenda, if any, thereto with each page signed and stamped shall be attached to acknowledge the acceptance of the same.

The bidder shall deposit Earnest Money Deposit for an amount of Rs. (₹) 35, 000/- (Rupees Thirty Five Thousand Only).

The Bidder (each member in case of joint venture/consortium/partnership firms) shall furnish the details regarding orders completed in preceding three years, which were similar in nature and complexity as in the present contract for providing Mathematica latest version perpetual desktop license.

Bid Prices

Bidder shall quote the rates in Indian Rupees excluding taxes for the entire contract on a 'single responsibility' basis such that the Tender price covers bidder's all obligations mentioned in or to be reasonably inferred from the tender document in respect of the cost including installation of Mathematica latest version perpetual desktop license at Kalindi College. This includes all the liabilities of the bidder. Conditional bids/offers will be summarily rejected.

9. **FORM OF BID** – All the documents attached with the bid shall be completed in all respects and duly signed and stamped by an authorized and empowered representatives of the Bidder. If the Bidder comprises a partnership firm, consortium or a joint venture, it shall be signed by a duly authorized representative of each member of participant thereof. Signatures shall be witnessed and dated. Copies of relevant power of attorney shall be attached.

Currencies of Bid and Payment – The Bidder shall submit his financial bid/offer in Indian Rupees and payment under this contract will be made in Indian Rupees.

Format and Signing of Bid

The bidder shall upload all the tender document and addenda, if any, thereto, with each page of this document signed and stamped to confirm the acceptance of the terms and conditions of the tender by the bidder.

The documents comprising the bid shall be typed or written in indelible ink and all pages of the bid shall be signed by a person or persons duly authorized to sign on behalf of the bidder. All pages of the bid, where entries or amendments have been made, shall be signed by the person or persons signing the bid.

10. SUBMISSION OF BIDS

Pre-qualification eligibility (Annexure III) and Technical Bid (Annexure IV) should consist of the following documents:

11. BIDDING PROCESS

Bid Opening and Evaluation

- The authorized representatives of the College will open the Technical Bids.
- The bid of any bidder who has not complied with one or more of the conditions will be summarily rejected.
- Conditional bids will also be summarily rejected.
- Technical bids will be evaluated as per the methodology given in the Annexure – III and IV of the Tender document.
- Financial bids for evaluation will be opened of those who qualify from Technical bids.
- Financial bid will be evaluated as per methodology given in the Annexure – VI of the Tender document.

Right to accept any Bid and to reject any or all Bids

- Kalindi College is not bound to accept any bid and may at any time by notice in writing terminate the tendering process.
- Kalindi College may terminate the contract if it is found that the agency is black listed on previous occasions by any of the Colleges / Institutions / Local Bodies / MNCs/ Public Sector Undertakings etc.

13. AWARD OF CONTRACT
