The term of the members shall be of two years. The term of the spl. Invitee shall be one year. The quorum of the meeting including the Chairperson, but excluding the spl. invitee, shall be three. The Committee shall follow the Principle of Natural Justice. The Committee shall send its report with recommendations, if any, to the Vice-Chancellor, University of Delhi and a copy thereof to the aggravated student, within a period of fifteen working days from the date of receipt of the complaint. Any student aggrieved by the decision of the Students' Grievance Redressal Committee may prefer an appeal to the Ombudsperson, within a period of fifteen days from the date of receipt of such decision.

A weekly report should be submitted by the committee on every Friday. In case, no grievance received, a nil report should be submitted.
